### II. Job Summary

Perform cleaning and maintenance for all campus buildings, grounds, equipment, and parish events as directed.

#### III. POSITION CONTENT

## A. Major Position Responsibilities and Regular Activities

- 1. Responsible for performing regular and preventative maintenance for all parish assets and property.
- 2. Perform set-up and clean-up for parish functions, including funeral visitations, funeral luncheons, and special events.
- 3. Work with festival committee in festival set-up and clean-up.
- 4. Schedules HVAC and Baptismal Font for campus events utilizing computer and programmable thermostats.
- 5. Follow proper protocol for cleanup of bodily waste, blood borne pathogens and other hazardous materials.
- 6. Other duties as assigned.

### IV. POSITION SPECIFICATIONS/REQUIREMENTS

### A. Skills, Knowledge and/or Abilities

- 1. Must have basic mechanical skills, i.e. HVAC, electrical, plumbing, painting, and carpentry.
- 2. Ability to work with various hand tools, power tools, lawn and garden equipment, and other power equipment.
